When ou visit our mobile application, and use our services, ou trust us with our personal information. We take our privac ver seriousl. In this privac notice, we describe our privac polic. We seek to explain to ou in the clearest wa possible what information we collect, how we use it and what rights ou have in relation to it. We hope ou take some time to read through it carefull, as it is important. If there are an terms in this privac polic that ou do not agree with, please discontinue use of our Apps and our services.

This privac polic applies to all information collected through our mobile application, ("Apps"), and/or an related services, sales, marketing or events (we refer to them collectivel in this privac polic as the "Sites").

Please read this privac polic carefull as it will help ou make informed decisions about sharing our personal information with us.

1. WHAT INFORMATION DO WE COLLECT?

Information automaticall collected

We automaticall collect certain information when ou visit, use or navigate the Apps. This information does not reveal our specific identit (like our name or contact information) but ma include device and usage information, such as our IP address, browser and device characteristics, operating s stem, language preferences, referring URLs, device name, countr , location, information about how and when ou use our Apps and other technical information. This information is primaril needed to maintain the securit and operation of our Apps, and for our internal anal tics and reporting purposes.

2. HOW DO WE USE YOUR INFORMATION?

We use personal information collected via our Apps for a variet of business purposes described below. We process our personal information for these purposes in reliance on our legitimate business interests ("Business Purposes"), in order to enter into or perform a contract with ou ("Contractual"), with our consent ("Consent"), and/or for compliance with our legal obligations ("Legal Reasons"). We indicate the specific processing grounds we rel on next to each purpose listed below.

We use the information we collect or receive:

Deliver targeted advertising to ou. We may use our information to develop and displace content and advertising (and work with third parties who do so) tailored to our interests and/or location and to measure its effectiveness.

Request Feedback. We may use our information to request feedback and to contact our about our use of our Apps.

For other Business Purposes. We may use our information for other Business Purposes, such as data analosis, identifying usage trends, determining the effectiveness of our promotional campaigns and to evaluate and improve our Apps, products, services, marketing and our experience.

3. WILL YOUR INFORMATION BE SHARED WITH ANYONE?

We ma process or share data based on the following legal basis:

Consent: We ma process our data if ou have given us specific consent to use our personal information in a specific purpose.

Legitimate Interests: We ma process our data when it is reasonable necessar to achieve our legitimate business interests.

Performance of a Contract: Where we have entered into a contract with ou, we ma process our personal information to fulfill the terms of our contract.

Legal Obligations: We madisclose our information where we are legall required to do so in order to complowith applicable law, governmental requests, a judicial proceeding, court order, or legal process, such as in response to a court order or a subpoena (including in response to public authorities to meet national securit or law enforcement requirements).

Vital Interests: We may disclose our information where we believe it is necessar to investigate, prevent, or take action regarding potential violations of our policies, suspected fraud, situations involving potential threats to the safet of an person and illegal activities, or as evidence in litigation in which we are involved.

More specificall, we man eed to process our data or share our personal information in the following situations:

Vendors, Consultants and Other Third-Part Service Providers. We may share our data with third part ovendors, service providers, contractors or agents who perform services for us or on our behalf and require access to such information to do that work. Examples include: payment processing, data analysis, email deliver in hosting services, customer service and marketing efforts. We may allow selected third parties to use tracking technolog on the Apps, which will enable them to collect data about how our interact with the Apps over time. This information may be used to, among other things, analy example and track data, determine the popularity of certain content and better understand online activity. Unless described in this Policy, we do not share, sell, rent or trade any of our information with third parties for their promotional purposes.

Business Transfers. We man share or transfer our information in connection with, or during negotiations of, an immerger, sale of companiassets, financing, or acquisition of all or a portion of our business to another compania.

6. HOW LONG DO WE KEEP YOUR INFORMATION?

We will onle keep our personal information for as long as it is necessar for the purposes set out in this privace police, unless a longer retention period is required or permitted be law (such as tax, accounting or other legal requirements). No purpose in this police will require us keeping our personal information for longer than 90 days.

When we have no ongoing legitimate business need to process our personal information, we will either delete or anon mi e it, or, if this is not possible (for example, because our personal information has been stored in backup archives), then we will secure store our personal information and isolate it from an further processing until deletion is possible.

7. HOW DO WE KEEP YOUR INFORMATION SAFE?

We have implemented appropriate technical and organisational securit measures designed to protect the securit of an personal information we process. 8. DO WE COLLECT INFORMATION FROM MINORS?

9. WHAT ARE YOUR PRIVACY RIGHTS?

10. CONTROLS FOR DO-NOT-TRACK FEATURES.

11. DO CALIFORNIA RESIDENTS HAVE SPECIFIC PRIVACY RIGHTS?
